Here he became friendly with the incredibly rich Jonny (Johann) Jebsen. Both were abducted on 30 April 1944 after 1900 hours in the offices of the KO in Lisbon. They were drugged and conveyed, in a car via Spain to Biarritz, from where they were flown to Berlin. Soon thereafter the RSHA became in charge and both men landed in the Sachsenhausen Concentration Camp. Jebsen was from there in February 1945 removed by an SS man and since his traces disappeared. Albeit, that the SS officer had been traced but this had, after all, no effect; Artist disappeared for ever.

oil project: Jebsen (Jonny) and Popov (Iwan) both were engaged in getting free an oil-tanker held in Sweden. This caused tremendous suspicion against Jebsen and might ultimately have caused his death.
